ProMax Power Direct Vent residential gas models are equipped with FVIR technology to meet Phase III of the ANSI Z210.1 - 4.1 CSA standards for the resistance to flammable vapor ignition and resistance to lint, dust and oil

The two-pipe closed-combustion system draws all make-up air from outside the home, eliminating problems caused by insufficient indoor

The system permits combined horizontal and vertical venting and air intake runs up to 45 feet (including one 90° elbow) using 3" Schedule 40 PVC, CPVC or ABS pipe for installation versatility.




