Application

Model SRT fans are roof curb mounted filtered supply fans rated up to 1256 CFM, with static pressure capabilities to 1.0 inch. The primary use of these fans is filtered make-up air in commercial and industrial applications such as manufacturing, restaurants, kitchens and assembly areas.

Model SRT's rugged design with heavy-gauge aluminum construction provides maximum weather protection, long life and the utmost in performance efficiency. The backward inclined centrifugal blower provides efficient air flow at low sound levels with higher static pressure capabilities to handle ducted air systems.

Filters are washable and are reusable to reduce maintenance cost. Easy access hood makes routine cleaning and maintenance fast and easy.

Model SRT is backed by a one year fan and motor warranty (see warranty details on page 3). All fans are factory test run before shipping for quality assurance.

Roof Curb: Prefabricated heavy-gauge galvanized steel, welded construction, 12" high with 1 1/2" wood nailer. Options include single and double pitch construction and additional curb heights.

Dampers: Motor operated for positive closure backdraft or automatic (counter balanced).

Solid State Speed Control (ships loose):

Soler Palau's solid state speed control is matched to the motor and wheel to allow continuous reduction in performance allowing adjustments of airflow for system balancing. CFM is reduced in direct proportion to motor speed reduction. Speed control is available for 115 or 230 volt single phase. Fan performance can be controlled from the ventilated area.

Special Coatings: Epoxy, Heresite and synthetic resin are available when special coatings are required.



The model SRT-10 is a roof mounted filtered supply fan rated up to 1256 CFM of airflow, with static pressure capability up to 1" w.g. It is ideal for replacing used/contaminated exhaust air with fresh filtered make-up air in commercial and industrial environments. The direct drive SRT unit includes a backward inclined nonoverloading wheel which is suitable for both ducted and nonducted applications. Model SRT's rugged heavy-gauge aluminum hood and stack provide maximum weather protection and long life in an elegant, low-profile housing. The washable 1" thick aluminum mesh filter is protected by the hood, yet is very easy to remove from the hinged hood. The 1-PH speed-controllable motor is open drip-proof and 115/208-230 volts, 60/50 HZ, 1625/1400 RPM for maximum versatility.

Soler & Palau USA (manufacturer), 6393 Powers Avenue, Jacksonville, Florida 32217, warrants equipment of its manufacture to be free from defects in design, materials and workmanship (exclusive of abrasion, corrosion or erosion) for one (1) year from the date of receipt or the date of shipment to the original purchaser or the date of notification of readiness to ship. Motor warranty is one (I) year. In order to claim the benefit of this warranty, buyer must notify manufacturer in writing of the claimed defect within ten (10) days after discovering it and return this equipment or parts to the factory with transportation prepaid. In the event of on-site repair, no service technician will be dispatched until manufacturer receives your written purchase order. If any of the following conditions exist, the warranty will be null and void: (1) Buyer has permitted other persons not approved or authorized by manufacturer to alter, adjust, replace or repair the equipment or any part there of. (2) Buyer has not followed instructions or other directions given in the contract documents or our maintenance manual. (3) When breakage or other loss or damage is the result of any negligence, misuse or fault on the part of any operator or other person not under our supervision or control. (4) The defect is the result of designs or drawings made, furnished or specified by others. (5) In the case of goods not manufactured but supplied by the manufacturer as part of a contract, manufacturer shall only be liable to the same extent that our supplier is to manufacturer, not to exceed any liability manufacturer would have for warranty on our own equipment. (6) Buyer has not paid in full any invoices submitted to buyer which are due for payment. (7) Unusual wear and tear of the equipment. Statements relating to the product, its use or installation made prior to the execution of the agreement, are not warranties except to the extent that the contrary is expressly set forth herein. 
