


# Model 950XLFDC

## **APPLICATION**

Designed for direct connection to fire hydrant on temporary construction water lines to protect against both backsiphonage and backpressure of polluted water into the potable water supply. NSFHT adapters allow for connection to  $2\frac{1}{2}$ " fire hydrant (inlet) and  $2\frac{1}{2}$ " fire hose (outlet). Assembly shall provide protection where a potential health hazard does not exist.



#### **TYPICAL INSTALLATION**

Local codes shall govern installation requirements. To be installed in accordance with the manufacturer's instructions and the latest edition of the Uniform Plumbing Code. i8Unless otherwise specified, the assembly shall be mounted at a minimum of 12" (305mm) and a maximum of 30" (762mm) above adequate drains with sufficient side clearance for testing and maintenance. The installation shall be made so that no part of the unit can be submerged.

#### **SPECIFICATIONS**

The double check type backflow preventer shall be ASSE® Listed 1015, and supplied with full port ball valves. The inlet connection shall be a 2½" female NST swivel and the outlet connection shall be a 2½" male NST coupling. The main body and access covers shall be bronze (ASTM B 584), the seat ring and all internal polymers shall be NSF® Listed Noryl™ and the seat disc elastomer shall be silicone. The first and second checks shall be accessible for maintenance without removing the device from the line. The double check valve shall be a WILKINS Model 950XLFDC.
